ADDRESSING A PRESS CONFERENCE AT THE EPHPHATHA HALL, CELESTIAL CHURCH OF CHRIST, AYILARA PARISH, SURULERE

I salute esteemed Shepherds and Elders of our dear Celestial Church of Christ; Executives of the Parish Management Committee and Members of Ayilara Parish. I salute also, gentlemen of the press.

This is a critical period in the history of the Celestial Church of Christ and everyone who wants to be on the right side of history must join us in the Unification of our great church. We all need to make personal and collective sacrifice to achieve Unification.

To this end I, SAMUEL OLUMUYIWA OSHODI hereby renounce my titles of Reverend and Deputy Pastor of the Celestial Church of Christ.

Henceforth, I revert to the 1985 title of Full Evangelist that the late Pastor/Founder, Reverend (Prophet) SBJ Oshoffa anointed me with. I will now be known and addressed as Evangelist (Prophet) Samuel Olumuyiwa Oshodi.

Today, I solemnly declare my 100 percent support for the Unification of the Celestial Church of Christ. There is a history behind this decision. Let me tell you some of it briefly...

After the demise of the Pastor/ Founder, Rev (Prophet) S.B.J Oshoffa of blessed memory, shepherds, trustees, and some high ranking honorary evangelists allowed the devil to set in through one Segun Amun who used diabolical items (cownes, half burnt candle and a small wooden cross) to proclaim Supreme Evangelist A.A Bada as Pastor.

These are some of the steps I believe must be taken by the 'Regents in Office' and their supporters in order to hasten the Unification process.

Step One: They should hasten to renounce their titles as 'pastors' and go back to their 1985 ranks because I am sure we have records at the International Headquarters, Ketu with 'Baba Yemisi'.

Step Two: They must take to prayer and fasting because they have tormented this great church and did not wait for the Lord to choose for us.

Step Three: Let them willingly join the GLOBAL UNIFICATION MOVEMENT immediately and wait for further instructions from God.

By God's grace this year, we will be hosting Ephphatha Crusade in the United Kingdom, in the United States, in the Republic of Benin where our church was founded by Papa Oshoffa of blessed memory; and we will host it on Friday, July 31, 2009 here in Lagos, Nigeria where it all started.

Ephphatha stands for the Unification of our church. It stands for healing, victory, deliverance, prosperity and supernatural blessings of all Celestians worldwide. We are not for any faction. Ephphatha is God's gift to Celestial Church of Christ Worldwide.

Long live Celestial Church of Christ Worldwide and long live God's obedient servants worldwide in Jesus name. Amen. Halleluyah! Halleluyah!! Halleluyah!!!

There Is No Love, Peace And Unity In CCC — Oshodi

Recently, Deputy Pastor of the Celestial Church of Christ (CCC), Reverend Olumuyiwa Oshodi, relinquished his office and stripped himself of his rank

Until his declaration, Oshodi was deputy to Pastor Paul Suru . Maforikan, who heads the second biggest division of the church. The 66-year-old reverend gentleman shocked members of the public when he alleged that all those parading themselves, as pastors of the 61-year-old church are self-serving impostors. In this Interview with GRACE OMOSHABA; Oshodi who 10 years ago began the largest open revival of the church named 'Ephphatha Crusade,' said he is determined to aggressively support the unification process.

Why did you change your title of Deputy Pastor to Evangelist?
I decided to do that by the spirit of God, which overtook me and arrested me. The anointing we had from Pastor A.A. Bada till date are null and void. Since the

pronouncement from the Supreme Court on Pastor Bada that he should not parade himself as Pastor of this church. Constitutionally he is

not a pastor. The late Pastor/

Founder, Reverend (Prophet) SBJ Oshoffa anointed me and conferred on me the titles I now bear. I do this as a personal sacrifice in order to declare my 100 per cent support for the. unification of the church because he who comes to equity must do so with clean

It was in 1985, before our pastor and founder died, he gave me the title Evangelist. I got the Deputy Pastor from Paul Maforikan.

But you should have rejected it then.

I didn't reject it because the Holy Spirit did not directing me. When the Holy Spirit took over me, arrested me, He said I should renounce it.

Does that mean that anybody in the CCC that is a pastor is not conforming to the constitution of the



Anybody who is a pastor now or deputy pastor is not conforming to the constitution of the church as pronounced by our late SBJ Oshoffa.

Your decision to renounce your title would have made your relationship with Paul Maforikan sour?

When we are declaring unification you should not belong to A or B, (if not) there will be division in the church. If I want to renounce it I should come out. We have diocese and the trustees. For unification sake, I should come out so that they will not see me as being part of any segment. If you want to unify the church you must be neutral.

Just like this one, several controversies have rocked the CCC in times past. Isn't it possible you are responsible for elongating especially among the people you left behind?

I want to take them along because everybody must be a part of the unification. If you are not part of'. the unification, it means you are against the pronouncement of the pastor founder; you are against the constitution too.

You have a constitution in the CCC, should someone just wake up one morning and annoint pastor?

They know the truth but they don't want to go by it. That's the problem we are having. They must come to unify the church in love, peace and unity.

How do you think you can correct these l'apses?

We are telling them to renounce their rank, go back to the time of the pastor founder, then we can move forward. They have abandoned all the projects we have here and there because there is no unity, no peace, and no love. The only way we can solve our problems is to come together and unify the church.
Forget about your rank. A life is a mission, not wealth, not power, position but ability to surrender totally into the hands of Jesus Christ. That is what many people have failed to do now.

We want to correct that in one love and unity. The CCC root is still there. We only need to correct ourselves

We'll go out and start propagating. We are going to say that they should stop anointing. People are not happy. They are disheartening. They don't love these things that are happening. God is not in disunity. He is not an author of disunity. He is a God of peace.

Now and beyond what is your vision for CCC?

We are propagating unification. We want to unify the church. There shouldn't be any division. We don't want conflicts, we want Christ to work in us as ever before. We want the solver of problems to solve our problems. We have abandoned projects that have not been completed. We cannot do it in isolation, if we come together we can.

The church is 61 years and you don't have a missionary building? We will have that

when we unify the church. We have abandoned projects here and there. One at

Imeko, Abeokuta / Ibadan Expressway can be revisited if we can have one voice. That is what I'm propagating for now, we come together for one purpose, one voice then we can move ahead, together in one voice, one love. We don't have to quarrel with one another. The Bible says in Mal. 2:10, "Are we not children of one father?" So, why are we now quarrelling? Unless we see ourselves as one, and recognise that, will we move ahead.

How soon will these changes take place?

As soon as we finish here toady; I have a lot of people that we want to do this together. They are also tired of the conflicts, division here and there. If you go to a parish, they'll ask you, 'are we not for Christ?' If they discover you are from Paul, they'll say: 'No,' you can't fellowship with us, That is ungodly, and that is what we want to remove now and we have to move forward, to propagate, talk to people. We are going to enlighten them.

What is your last word for all CCC members?

To keep CCC one is a task that must be done all over the world Jesus is in control already. It is not by my might or power, it is by God's grace: He is using me for this. I don't think I can do it by myself

Just two weeks ago, I got two sets of my garments; I can't use it any longer. Now I want to put it aside and start wearing the ones I used a long time ago in 1985, 1 want to go back , to it. It is a sacrifice, you humble yourself, go back to Jesus and pray fervently so that He will answer. Jesus is the owner of the CCC, whether we like it or not, He hears our prayer and that is what He told me to tell people.

ntil mid-January this year, most members of the Celestial Church of Christ (CCC) knew Prophet Olumuyiwa Samuel Oshodi, 66, as Reverend and Deputy Pastor. He was said to be a major sup-porter of Pastor Paul Suru Maforikan who heads the second biggest division of the 61-year-old white garment church.

But on Tuesday, January 27, 2009 Oshodi addressed a huge crowd of followers and a cross-section of the news media at a press conference. He declared his total at a press conference. He declared his total support for the unification of all factions of the church and his personal sacrifice of stripping himself of his acquired titles of Reverend and Deputy Pastor and the paraphernalia of pastoral responsibilities and apparels attached to those titles.

Oshodi who has now returned to his 1985 title of Evangelist/Prophet – incidentally that was the rank given to him and seven others by the late founder of the church, Reverend Samuel Bilehou Joseph Oshoffa –also announced his disengagement from every perceived divi-

engagement from every perceived divi-sion or power bloc within the church in order to reinforce his declaration for unification.

Exclusive information reaching me confirms that since the demise of Oshoffa 24 years ago, the church has been engulfed by spiritual rascality, financial impropri-

by spiritual rascality, financial impropriety and the usurpation of the office of pastor by different people parading themselves as heads of the church.

Said Dr. Michael Adedoyin, a prophet and secretary-general of Ephphatha, the largest crusade of the CCC which has Oshodi as its founder and president: "Papa Oshodi is the first Celestian in any high ranking pastoral office who would disrobe himself, renounce his acquired titles and revert to a 24-year-old rank in order to be taken seriously as a sincere and genuine icon of unification.

rascality, financial impropriety and the usurpation of the office of pastor by different people and for which reason many cases have been taken to the police and some to the courts.

On the issue of pastors and trustees of the church, Oshodi said: "Today's so called pastors have tormented our great church and have made it a church and have made it a family affair. They should all disrobe and join the CCC Unification Worldwide. We all must wait upon the Lord to choose the right pastor.
"If there are any differences between Pa Owodunni and Pa Banjo-both of whom are the last the action of the control of the contr

Banjo-both of whom are the last two surviving trustees of the church that were appointed by Papa Oshoffa – they should please settle for God's sake and restore peace and legitimacy over the church before they die." Oshodi, who 10 years ago began the largest open revival of the church named 'Ephphatha Crusade', said he was determined to aggressively

was determined to aggressively use the crusade which his parish, CCC Ayilara, hosts annually to support the

annually to support the unification process.

"This year, as we mark our 10th anniversary, we will be hosting Ephphatha Crusade in the United Kingdom, United States of America, Benin Republic where the church was founded by Pany Ocheffe and

republic where the church was founded by Papa Oshoffa and here in Lagos, Nigeria."


Unconfirmed reports say that in the heat of Oshodi's renunciation, a bewildered Pastor Paul Maforikan flew out to London only to phone in to confide in some people that he was also ready to renounce his pastoral title for peace to reign in the church. However, this remains to be proven.

Press men attended the conference from all major news media including the News Agency of Nigeria (NAN). It was apparent that quite a few of them knew a bit of the history of the church. One asked Oshodi if he wasn't setting the stage for his own ascent to the seat of pastor of another faction of the embattled church.

I was moved by Oshodi's

response.
"I say it publicly here, even if



these shepherds and high ranking elders of the church who surround me today (and there were over 500 of them in the hall) hail me and say they

the hall) hail me and say they want me as pastor, I will decline.

"I am not doing this for any personal gains. Indeed, I am not doing this for any man. I am being propelled by the Spirit of God in me. About a month ago, God told me clearly that I had abandoned the mission of unification of the Celestial Church of Christ in preference for rank and title, which He didn't approve for me.

"I woke up a renewed person. Left to me, I probably would have continued to wear the robes of Deputy Pastor, but if God has instructed me to take those robes off, then I can't join

those robes off, then I can't join the fray and declare myself pastor or allow some people push me into it. No, I won't take such a thing. I just want to see our great church united again,"

Well, it all sounds good, but just as I warned Pastor Adeboye of the Redeemed Christian Church of God – to ensure he handpicks his successor in his lifetime otherwise RCCG will experience worse breakup than the C & S and Celestial Church - I also must sensitise the

emerging unification movement in the CCC.

The two surviving original trustees of the church, octogenarian Pa Josiah Kayode Owodunni and septuagenarian Samson Olatunde Banjo, must move fast to bury their egos and reunite the church while they are still alive, so they can forestall further disintegration of the church. For decades, both of them, like the four other original trustees (all dead), have

apparently paid only self-serving lip service to the idea of unification since the demise of Oshoffa. They can right their

Oshoffa. They can right their wrongs now!
Disrobing and renouncing titles is a huge and praiseworthy sacrifice from one man, but no single tree can make a forest. To bring together all the mushrooming pockets of unification efforts in the church is noted. But it must be done in unification efforts in the church is good, but it must be done in ways that encourage other powerbrokers of the church to embrace unification as there own, not as Oshodi's or indeed some other icon's.

But beyond disrobing and appropriate titles what the

renouncing titles, what the Celestial Church needs is a comprehensive constitutional review and rebranding (or image re-engineering). The numerous media reports about prophets and prophetesses of the church calling some people witches and burning their hands or bencheds hands or shepherds confiscating other people's wives, etc are rife and these paint a church black in the sight of right thinking persons. Again, when the Supreme Church disrobed one of the

church's erstwhile pastors, Rev. Abiodun Bada, in 2000 and told him not to parade himself as pastor any longer, it also told the church to review its constitution and make it a proper document on certain fundamental issues like succession.

In addition to that, the church needs to review a constitutional provision called 'Pastor's Share' which converts almost all the wealth of the church into the personal possession of whoever is its pastor.

Anyone will kill and lie in God's name for such unfettered

riches and as long as that subsists, drama of the absurd will continue to play out on the Celestial stage as men damn all consequences to declare consequences to declare themselves pastor to also get their grubby fingers into the church till. Even an angel from heaven stands to be corrupted of 'killed' (ha, ha) if sent to rule
