THE IMPLICATION OF THE 30TH JUNE 2000 NIGERIA SUPREME COURT, AS WELL AS THE 26TH MARCH 2015 ILARO HIGH COURT JUDGEMENTS ON CCC NIGERIA DIOCESE MEMBERSHIP, ESPECIALLY THOSE LEADERS WHO ADORN THEMSELVES IN PASTORAL ROBES AND ACTUALLY PERFORM THE DUTIES OF A NONE EXISTENT POST OF PASTOR IN NIGERIA DIOCESE AND IN THE DIAS PORA INCLUDING THE AMERICAS.

It may be noted that above captures subsisting scenario as it affects the various Factional Leaders in CCC who include:

'Revds' (Not a CCC tittle but just as a honourable word of respect)

- a. Maforikan Paul Suru
- b. Orovboni Stephen Erubasi
- c. Oshoffa Emmanuel Friday
- d. Owodunni Josiah Kayode
- e. Adetunji Johnson Banji
- f. Shonekan Godwin Bolanle

In view of the various unification activities to date and consequent upon the judgement of the Ilaro High Court and that of the Supreme Court, the following are the implications and which all members of CCC are enjoined to ensure compliance.

- That as at today, there is no Pastor in the Church Worldwide and will not be any until we have a convocation of a World Committee/Commit Mundial;
- Those factional Heads parading the iselves as 'Pastor' of the Church W/W should stop forthwith as they will be in contempt of the Court pronouncement.

- 3. That all those factional Heads adorning themselves in pastoral regalia should stop forthwith as they are in contempt of the Court pronouncement and could be jailed for contempt of Court
- 4. As of the 'Pastors" above, all positions /ranks and dresses created after the death of SBJ Oshoffa has been consequently nullified and should be discarded
- 5. That having regard to the judgment of the Ilaro High Court which did not proclaim any of the contenders as 'Pastor', all anointment of members of CCC W/W should be stopped forthwith and members are enjoined to stop taking anointment from anyone now as doing so will be in contempt of the Court
- 6. All members of CCC W/W are enjoined to cooperate with the Unification Group and the CCC Nigeria Diocese Transitional Elders Council to ensure that lasting peace return to the Church in Nigeria, to enable them enthrone constitutional order, a Diocesan Governing Council /Nigeria Diocese General Committee leading the Church to the establishment of the world Governing Council/World Committee/Commit Mundial
- 7. These two judgments thereby put paid to all other Court cases on issues relating to the Factions and Pastorship.
- 8. Anytime from now a meeting of all Stakeholders holden in CCC National HQ in Makoko Yaba, Lagos will be convened:
 - (a) to showcase the activities of CURM over the years as laid down preparatory to the present day unfolding scenario in the CCC public today;
 - to present the 33members Modalities Committee's new Nig. Diocese constitution as amended by prominent CCC members which include; a Rtd Justice, a serving Chief Magistrate and practicing Lawyers in line with the 1980 Nig. Diocese constitution; and

(c) to set up an Implementation Committee to kick start the implementation of all recommendations of the adopted constitution under the aegis of the CCC Nig. Diocese Transitional Elders Council already inaugurated in CCC National HQ. in Feb. 2013.
